Manual Handling Course

The Manual Handling Course can be tailored to suit individual workplaces. It is highly interactive and involves both theory and practical sessions. The instructor assesses the learner in safe handling techniques and the principles of safe moving and handling. Over 30% of accidents reported to HSA annually result from manual handling. 50% of people who are off work with back pain have a recurrence within one year. 5% of back pain injuries can lead to prolonged disability. It's equally common among males and females. The definition of Manual Handling can be found in the Guide to the Safety, Health and Welfare at Work (General Application) Regulations 2007, Chapter 4 of Part 2: Manual Handling of Loads. We also offer Public Manual Handling Courses in our training centre in Longford and online. Please note that the online course is an awareness course only; you will also need further practical training. Please get in touch with us to arrange this.



People Moving & Handling Course

The People Moving & Handling Course incorporates Risk Assessment and will ensure that your organisation complies with the HSA, HSE, and HIQA patient/resident moving requirements. Learners will understand how to use equipment using the recommended best methods and safe techniques and how to protect the dignity of the patient/resident.

[The Manual Handling Section of the Course can also be delivered through blended learning.](#) The first option should be to eliminate or reduce the need for manual handling. The HSA provides [guidance](#) explaining how this can be achieved. Just providing training will not reduce injury rates and will not protect anyone. The training needs to be specific and relevant to the tasks involved. So, if your job involves moving or supporting a person within a healthcare premise, the training should reflect this. In other words, you don't just need to be told how to lift a box.

The [Safety, Health and Welfare at Work Act 2005](#) places considerable statutory responsibility on employers and managers; we also offer a [Safety Management Course](#). The course gives an overview of the duties of the employer and the employee under the Safety Health and Welfare at Work Act 2005 and the [Safety Health and Welfare at Work \(General Application\) Regulations 2007](#).



Risk Assessment Training Course

The Risk Assessment Training Course is designed to give learners theoretical and practical knowledge in risk assessment. It will outline the general responsibilities and requirements under current occupational health and safety legislation. The course will ensure employers meet the requirements to comply with the [Safety, Health and Welfare at Work Act 2005, Section 19](#). Law, specifically Section 19 of the Safety, Health & Welfare at Work Act 2005, places responsibility on employers and those who control workplaces to any extent to identify hazards in the workplaces under their control and assess the risk presented by the hazards. Risk Assessment aims to reduce the risk of work-related injury and illness. Ultimately, assessing risk means that anything in the workplace that could cause harm to your employees, other employees and other people (including customers, visitors and members of the public) must be carefully examined. This allows you to estimate the magnitude of risk and decide whether the risk is acceptable or whether more precautions must be taken to prevent harm.

Safety Representative Training Course

Our Safety Representative Training Course follows the content recommended by the Health and Safety Authority. The course aims to give general guidance on the roles of Safety Representatives and employers and the employees' responsibilities in safety consultation and representation so that accidents and ill-health at work can be prevented. Employer and employee consultation on safety, health, and welfare concerns should occur in general and between the employer and the safety representative(s) designated by the employees. Workers will be inspired to do more to ensure compliance if they see their organisation succeeding in promoting safety and health. The best approach to getting workers engaged in formulating and reviewing safe work practices is to get them to follow them. Workers are far more inclined to follow processes when implemented if they believe their thoughts are appreciated and considered. After all, workers are the ones who do the work, and they will know it better than anybody else.



Safety Managers Training Course

The Welfare at Work Act 2005 places considerable statutory responsibility on employers and managers. The course focuses generally on both and specifically on the manager's role. Under the Safety, Health, and Welfare at Work Act 2005, responsibility for safety and health is placed directly on those in charge of the workplace. In other words, directors and managers who control the work must take on this responsibility. This Safety Managers Training Course will give managers an overview of their roles and responsibilities for a company's day-to-day health and safety needs. The course will set out to provide participants with the basic arrangements and provisions that need to be in place about the Safety, Health and Welfare at Work Act 2005 and the [Safety and Health and Welfare at Work \(General Application\) Regulations 2007](#). Evacuation Equipment (SWL 120kgs)

AlbacMat (Large)

First designed in 2002 for the Aged Care/Hospital markets, the AlbacMat Rescue Mat is widening its market appeal to include the Defence, Emergency Services and Mining industries. Other markets are continually opening up. The AlbacMat is an Emergency rescue mat designed to slide over all surfaces. It is a stretcher-like design, with polypropylene filling half the size of a rolled-up sleeping bag in storage. Constructed with heat-resistant material, it is moved by a rescuer – enabling rescues to be performed as fast as possible.



Evacuation Ski Sheet

The Evacuation Ski Sheet has been used in high-profile fires; the best example was the Royal Marsden Hospital Fire in London in January 2008, when a complete hospital evacuation was required. This included the evacuation of the ICU and operating theatres, where one patient underwent extensive surgery. Staff at the hospital evacuated more than 40 patients from the fourth floor on their mattresses, using the Evacuation Ski Sheet, which was available on each bed.




